2. The registered office of the Trust shall be located at Chorada, Jajpur Road, Dist – Jajpur, Orissa or at any other place as Trustees decide as and when necessary.
3. The authors of the Trust have purchased below scheduled land where the School building is existing and the School is functioning at present and that will form part of the property of the Trust.
4. All the movable and immovable properties of the Vyasagar Public School will be vested with the Trust.

THE AIMS AND OBJECTIVES OF THE TRUST.

- (a) The objectives for which the Trust is established are :
To cater education and advancement of any other object of general public utility more particularly for the lower, lower middle class people of the society.

- (b) To promote, support, maintain, control and management of the "Vyasagar Public School", Chorada, Jajpur Road and regulate its Managing Committee to run the school for the benefit and furtherance of education of the said school for this purpose. Trust is the final authority in matters relating to administration, finance and welfare of the school.
- (c) To grant scholarship, prizes, rewards, allowances and other financial assistance to meritorious students of Vyasagar Public School.
- (d) To establish a health centre in Vyasagar Public School for routine medical check up of the students and poor children of the locality.
- (e) To establish new school in different places to cater to the education of the children.
- (f) To take up activities for promotion of environment and ecological balance.
- (g) To engage in various philanthropic acts without any profit motive.
- (h) To grant relief to the people to the people affected by earthquake, flood, fire, famine and other natural calamities of similar nature.
- (i) To accept donations, gifts and endowments to fulfill the objective of the trust.
- (j) Generally do all such other things as are incidental or conducive to the attainment of the above objectives.

POWER AND FUNCTIONS OF THE TRUST


General management and control of the Trust for the purpose of managing the Trust affairs and properties shall vest with the Trustees. For the furtherance of the objectives of the Trust the Trustees shall have the following powers.

- a) To take charge of the existing managing committee of the Vyasagar Public School and to form suitable managing committee from time to time to assist them in day to day affairs of the school.
- b) To accept any donation, contribution, grant or subscription in cash or in kind including any property from any person, body of persons, company or Trust either from within India or abroad on such terms and conditions as Trustees may think fit and proper.
- c) To apply the whole or part of the Trust fund or any or more of the objectives of the Trust as Trustees may decide from time to time.

- d) To borrow money for the purpose of the Trust and management of its properties.
- e) To let out or demise any immovable property comprise in the Trust fund for such period and or such rent on such terms and conditions as the Trustee in their absolute discretion may think fit.
- f) To open account with any nationalized banks in the name of the Trust, to operate such account and to give instructions to the bank that such account may be operated by the Trustees or by one or more agents appointed by the Trustees.
- g) To appoint legal advisor to appear and act in all courts, civil, revenue or criminal whether original or appellate in the registration offices or in any other office of Government or District board, Municipal board, or any other local authority to sign and verify plaints, written statement, claims and objections, memorandum of appeal and applications of all kind and to file them in any such court, to compromise, compound or withdraw cases and to refer cases to arbitration on behalf of the Trust.
- h) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on him/her under these presents and from time to time remove such attorneys or agents and appoint other in his/her place.
- i) To vary, alter or modify schemes, rules and regulation for carrying out the objectives of the Trust and for the management of the affairs thereof and of running any institution in furtherance of the objectives of the Trust and otherwise for giving effect to the objectives of the Trust.
- j) To start, abolish, discontinue or start any charity or charitable institution.
- k) To accumulate the income of the Trust and apply the accumulated income for one or more of the objectives.
- l) To pay all charges, impositions and other outgoings payable in respect of the Trust fund or any property comprised in the Trust and also to pay all costs and incidental to the administration and management of the Trust fund for the time being.
- m) To appoint and/or dismiss officers or other employees to look after and manage the properties constituting the Trust fund and to allot to such persons such duties as the Trustees may think fit and proper.
